Maggie,

Thank you for passing along the presentation materials. Yesterday we spoke on the phone about the advertising for and content of the upcoming Fleisher Jacobs seminar at the VBA mid-winter meeting. After those conversations and after reviewing the slideshow you provided, it is clear that the CO-OP is approaching the line of solicitation without a certificate of authority, if not breaching that line. I appreciate that the CO-OP has made efforts to not mislead Vermonters about the CO-OP's licensure status. However, simply pointing out that the CO-OP is not licensed does not then permit solicitation in the form of a discussion of the CO-OP's extensive experience in insurance, its intention to "put people before profits," or its plans for "cooperation, progress, health improvement and innovation." Such a discussion could easily be interpreted as solicitation under 8 V.S.A. § 3368, regardless of the mention that the CO-OP is not yet licensed and is not guaranteed to be.

Going forward, we expect that slides 14 and 15 will be eliminated from the materials presented by Fleischer Jacobs Group. Further, we expect that neither FJG, the CO-OP, nor anyone else in any way affiliated or associated with those entities will publicly discuss the proposed Vermont Health CO-OP or its merits outside of the March 1 hearing. Any discussion in public should be limited to objective information found in the Affordable Care Act and associated regulations about CO-OPs generally.

This email and the presentation you provided will become part of Docket #12-041-1. Because the presentation has been used in public previously, I assume there is nothing you wish to keep confidential. If that is not correct, please advise as soon as possible whether you believe anything should be redacted, and address with specificity any such information.
