I am writing to update you regarding changes to the data filing requirements for 2012 required under Rule H-2009-03 ("Rule 9-03").

Attached are the Appendices from the forthcoming Rule 9-03 Implementation Manual, which are designed to assist MCOs with the July 15, 2012 data filing. Appendix A contains data filing instructions and checklists designed to assist MCOs in assuring that all filing requirements are met.

The updated data collection tables are included in the following attachments:

- 2012 Tables CAHPS 2010 11-19.xls
- 2012 Rule H-2009-03 Tables 1-8 2011 12-20.xls

These attachments have been updated to reflect the HEDIS® and CAHPS® measures in NCQA's 2012 technical specifications.

In addition, the following Rule-specific tables that were included in last year's filing have been removed:
